**ASSEMBLY POINT** The green behind the Church. Access is from Richmond Road, not Lansdown Road.

**FIRE EXITS - The main entry / exit doors onto Lansdown Road.** The door is always open during meetings.

**The emergency exit towards Richmond Road.** Go past the disabled toilet, the office and the toilets. Then open the door directly in front of you to access the emergency 'PUSH BAR' door.

**The emergency exit to the rear of the Church.** From the stage, go through the door to the vaults. Then go through the door directly in front of you. Go up the stairs and the emergency door, with THUMB SCREW BOLT, is directly in front of you across the room. St Stephen's have been asked if the lighting arrangements for this rear exit could be improved.
